

# **IFIA Financial Report - 2007**

#### General remarks

- The IFIA budget (the disposition of IFIA bank accounts) was received by the IFIA President after his election from May 2006 actually. Therefore the report regarding 2006 is incomplete staring from May 1, 2006. The report regarding year 2007 is complete, from January to December.
- IFIA has an UBS (Switzerland) bank account consisting USD, EUR and from year 2007 HUF sub accounts. The different currencies are shown in USD too for the comparison.




Figure 1. – Composition of our income

- The incomes were member fees and MAFE contribution only (see *Figure 1*.).
- The expenses were: Cost of IFIA activity (projects e.g. GENIUS 2006, invention shows, World Cup of CIIs, conferences, meetings, information, connections, representation, traveling, office etc.).
- The IFIA accounting was determined according the EU-Hungarian orders. The IFIA account documents are public for its members.

## Management

The management of IFIA was economy without any financial problem thanks to the MAFE contribution. The member fee payment activity was moderate, although the amount of member fee is symbolic only.

The voluntary work was the basic of the IFIA Office activity, the IFIA has no employees.

The IFIA Office covered hotel costs and travel compensation to participate different Budapest events. Several IFIA members provided free of charge services (booth, hotel, travel etc.) for the brother organizations.

Results of IFIA management are shown on the *Table 1*.

The great majority (86%) of our income was paid by the Association of Hungarian Inventors (MAFE) thanks to the Hungarian governmental support.

The member fees were paid in USD by Asian, American, European and Australian members mainly. The member fees were only paid in EUR by two European IFIA members. The MAFE contribution was paid in HUF.




Figure 2 – Balance (Amounts in USD)

IFIA initial in year 2007 (total in USD) was 17 824 USD and plus income 166 080 USD given our financial basis which was 183 904 USD. The all IFIA expenses in 2007 were 154 560 USD. The balance on December 31, 2007 was 29 344 USD. This amount is higher then before (see *Figure 2*.)
